NOTICE OF ADOPTION

BY-LAW NO. 2010-11

OFFICIAL PLAN AMENDMENT NO. 13 (BARRIE AGRICULTURAL SOCIETY)

TAKE NOTICE that the Council of the Corporation of the Township of Essa has passed By-law No. 2010-11 on the 3rd day of March 2010, under Section 22 of the Planning Act, R.S.O., 1990, c. P. 13) adopting Official Plan Amendment No. 13. Council has fulfilled all requirements under the Planning Act and is satisfied that the Official Plan Amendment is suitable for adoption and implementation. The Official Plan Amendment will now be sent to the County of Simcoe for approval.

THE PURPOSE AND EFFECT OF THE PROPOSED AMENDMENT is to change the Official Plan designation of 4762 20th Sdrd., Pt. West Half Lot 21, Concession 10 to a site-specific exception to the Agricultural designation to permit a range of uses as put forward by the Barrie Agricultural Society.

The property is located within Pt. West Half Lot 21, Concession 10 (see key map attached).

Additional information relating to the proposed amendment is available for inspection at the Township of Essa, Planning and Development Department during regular office hours. The subject land is also the subject of an application to amend the Zoning By-law for the Township and site plan approval.

The Official Plan Amendment will now be sent to the County of Simcoe for their review and approval. Any person or public body will be entitled to receive notice of the decision of the County of Simcoe, County Planning Department, if a written request to be notified of the decision is made to the County of Simcoe. 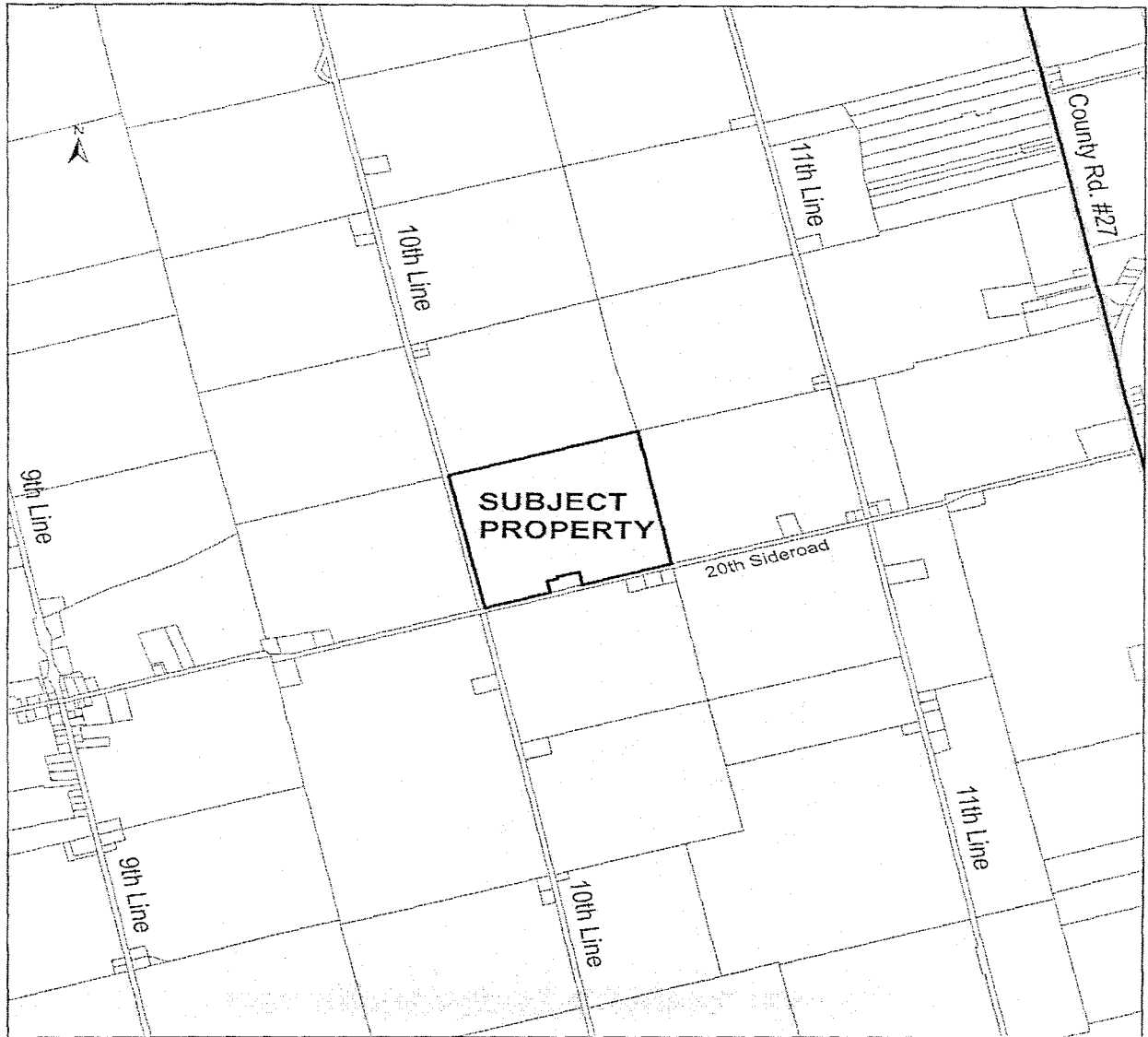
