

THE CORPORATION OF THE TOWNSHIP OF ESSA

BY-LAW 2010 - 24

A By-law of The Corporation of the Township of Essa to establish and assume for public highway purposes Cunningham Drive, Plan 51M-639; Henry Street, Plan 51M-639; Meadowland Boulevard, Plan 51M-639; Evergreen Lane, Plan 51M-639; Block G, Plan 1605; and Block I, Plan 1605; in the Township of Essa, County of Simcoe, being all of PINS: 58116-0300 (LT); 58116-0301 (LT); 58116-0302 (LT); 58116-0303 (LT); 58116-0304 (LT); 58116-0177 (LT) and 58116-0178 (LT)

WHEREAS the Municipal Act, S.O. 2001, c. 25, Sections 26 and 31, authorizes municipalities to pass by-laws for establishing highways for public highway purposes; and

WHEREAS Cunningham Drive, Plan 51M-639; Henry Street, Plan 51M-639; Meadowland Boulevard, Plan 51M-639; Evergreen Lane, Plan 51M-639 in the Township of Essa, County of Simcoe, being all of PINS: 58116-0300 (LT); 58116-0301 (LT); 58116-0302 (LT); 58116-0303 (LT); and 58116-0304 (LT); were dedicated to The Corporation of the Township of Essa by Plan 51M-639 registered on July 15, 1999; and

WHEREAS Block G, Plan 1605 and Block I, Plan 1605 in the Township of Essa, County of Simcoe, being all of 58116-0177 (LT) and 58116-0178 (LT) were transfered to The Corporation of the Township of Essa by Instrument No. RO368481 on September 8, 1971; and

WHEREAS the Council of The Corporation of the Township of Essa deems it necessary and expedient to establish as highways for public highway purposes the following land:

Cunningham Drive, Plan 51M-639; Henry Street, Plan 51M-639; Meadowland Boulevard, Plan 51M-639; Evergreen Lane, Plan 51M-639; Block G, Plan 1605; and Block I, Plan 1605 in the Township of Essa, County of Simcoe, being all of PINS: 58116-0300 (LT); 58116-0301 (LT); 58116-0302 (LT); 58116-0303 (LT); 58116-0304 (LT); 58116-0177 (LT) and 58116-0178 (LT)

NOW THEREFORE the Council of The Corporation of the Township of Essa enacts as follows:

1. That the following lands are hereby established as highways and assumed by The Corporation of the Township of Essa for public highway purposes:




